# SUBMISSION GUIDELINES

**Abstract Submission** - Authors are invited to submit an abstract not exceeding 500 words. The abstract should be clear and concise, providing a brief introduction to the topic, the intended research focus, and the expected conclusion. Abstracts can be submitted via this [link](#).

- Title of the Paper to be at the top.
- Name of the Authors to be written under the title in the following format: Name, Designation, Affiliated organisation; Co-author Name, Co-author Designation, Co-author Affiliated Organisation (if any)
- *Font*: Times New Roman, 12 for body, 14 for headings, and 10 for footnotes.
- *Margins*: Top, Bottom, Left and Right - 2.5 cm.
- *Spacing*: Line spacing of 1.5 for text and 1.0 for footnotes.
- *Alignment and Layout*: Justified text, A4 size.
- *Citation Style*: Bluebook 20th edition.
- *Plagiarism Policy*: Papers with plagiarism exceeding 10% will be automatically disqualified. Use of generative AI is prohibited.
- Co-authorship of upto 2 (two) authors is permissible. Separate registration fee to be paid by both.
- Abstracts to contain keywords at the end in the following format: Keywords: xvn, zcb.

# SUBMISSION GUIDELINES

**Complete Paper Submission** - Once the abstract is accepted, authors must submit their complete papers adhering to the following guidelines:

- *Font:* Times New Roman, 12 for body, 14 for headings, 12 for sub-headings, and 10 for footnotes.
- *Margins:* Top, Bottom, Left and Right - 2.5 cm.
- *Spacing:* Line spacing of 1.5 for body and 1.0 for footnotes.
- *Word Limit:* Maximum 15,000 words (including footnotes).
- *Page Numbers:* Bottom center.
- *Alignment and Layout:* Justified text, A4 size.
- *Citation Style:* Bluebook 20th edition.
- *Originality:* Submitted papers must be original, unpublished, and not under consideration elsewhere.
- *Plagiarism Policy:* Papers with plagiarism exceeding 10% will be automatically disqualified. Use of AI is prohibited.
- Co-authorship of upto 2 (two) authors is permissible.

Complete papers are expected to be submitted for holistic evaluation and feedback.
